City Council Chamber, City Hall, Tuesday, August 11, 2015

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, August 11, 2015 with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dave Martin, Richard Nguyen, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, and C. O. "Brad" Bradford, Jack Christie D. C., Mr. Harlan Heilman, Division Chief, Claims & Subrogation Division; and Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office, present. Council Members Dwight Boykins and Oliver Pennington absent on personal business.

At 1:40 p.m. Mayor Parker called the meeting to order and stated they would start with the presentation portion of the City Council meeting. Council Members Stardig, Davis, Cohen, Laster, Green, Robinson, Bradford and Christie absent.

Council Member Martin invited Dr. Kirk Lewis and his wife to the podium and stated that Dr. Lewis was presently the superintendent at Pasadena ISD presiding over 63 Campuses and in addition to some of his duties, he began a new ministry in 2013 by publishing his first book called" Put Away Childish Things" which everyone could probably take a little bit of knowledge from that book, it won the Christian Writers Award in 2014 and won powerful reviews for its imaginative writing and had he also recently published another book called "The Chase"; it was a great opportunity for him to introduce Dr. Lewis on some of his accomplishment for the past 30 years as a Superintendent, starting as Administration and Public Relations and Government Affairs, when taking over as Superintendent he had addressed facilities needs to create a thriving 21st Century learning environment that integrates technology into everything they do, had successfully passed bond elections that were valued at \$1.3 billion and had opened up 9 middle schools, 2 intermediate schools, 2 high schools, 20 replacement campuses and had also refurbished the district athletic stadium and as of June 23, 2015 he announced his plans to retire from his 30 years tenure with Pasadena ISD and would be honored by the City of Houston for his many contributions and therefore Mayor Parker proclaimed August 11, 2015 Dr. Kirk Lewis Day in Houston Texas. Council Members Stardig, Davis, Gallegos and Robinson absent.

Council Member Green stated he would like to present the Small Contractor Rotation Program which was developed by Houston Public Works and Engineering Department that was a two race, gender and neutral program that was designed to build a capacity of small construction contractors, the program was design to transition these contractors into prime contractors status; the Small Contractor Program Rotation Program would ultimate create a large pool of qualified prime contractors for the future of the City of Houston Projects, this aspects of the program in turn would reduce the overall cost of future projects and Public Works had reached out to the City Controller Office, the Office of Business Opportunity and 7 private businesses, organizations to help achieve these goals and requested each representatives of the partners to stand up and the City of Houston appreciate each of the representatives for lending a hand to make this possible and therefore Mayor Parker proclaimed August 11, 2015 as Small Contractor Rotation Day in Houston Texas. Council Members Davis, Martin and Robinson absent.

Council Member Kubosh invited the jazz honorees to the podium and Mr. Kyle Turner and Mr. Joe Carmouche played for Members of Council and Council Member Kubosh stated that jazz had been a big part of the United Stated and a big part of Texas, developed in the United States in very early part of the 20th century, New Orleans played a key role in the development and jazz emerged as a unique style of music from a blend of rag time, marches,

blues and other kinds of music, the City of Houston was home to many cultures and festivals like the Houston Jazz Festival that provides entertainment for Houstonians and on August 11, 2015 the Houston Jazz Festival would be honoring the Houston African American Jazz Makers and the Jazz enthusiast who would be honored included LaLa Wilson a Jazz Bassist, Kyle Turner a Jazz Saxophonist, Joe Carmouch a Jazz Guitarist, Yvonne Washington a Jazz Vocalist, Denise Seals a Jazz Vocalist, Kiland Kyham a Jazz Vocalist, Al Campbell for Jazz Education, Sam Pink for Jazz Entertainment and Events, Oscar McGarr for Jazz Promotions, Walter Strickland for Jazz Promotions, Larry Johnson for Jazz Radio Personality and Lloyd Hughes a Jazz Keyboards and therefore Mayor Parker proclaimed August 11, 2015 as Houston African American Jazz Music Maker Day in Houston Texas. Council Members Davis, Martin, Laster, Green and Costello absent.

At 2:18 p.m. Mayor Parker recognized Council Member Kubosh for the invocation and pledge of allegiance, and Council Member Kubosh invited Nancy First to the podium for the invocation and Council Member Kubosh led the pledge of allegiance. Council Member Costello absent.

At 2:23 p.m. City Secretary called the roll. . Council Members Dwight Boykins and Oliver Pennington absent on personal business. Council Member Costello absent.

Council Member Gonzalez moved to adopt the minutes from the previous meeting and seconded by Council Member Bradford and Council Member Kubosh moved that the adoption of the minutes be delayed for one week and seconded by Council Member Gonzalez, all voting aye, nays none. Council Members Gallegos and Costello absent.

Council Member Gonzalez stated he wanted to recognize some very special leaders that had been with them since the summer and unfortunately they would be losing them this week, Shu T Revcar from University of Pittsburgh and Christian Grey from Houston Baptist University. Council Members Stardig and Costello absent

Council Member Nguyen stated he wanted to recognize a special group of folks from District F, the Alief YMCA. Council Members Stardig and Costello absent.

Mayor Parker stated that they were joined by number of representative from AARP Houston. Council Members Stardig, Gonzalez and Costello absent.

Council Member Kubosh moved that the rules be suspended for the purpose to adding Ms. Jackie Abert to the list of speakers and to hear from Ms. Tolloria Allen out of order and seconded by Council Member Green, all voting aye, nays none. Council Members Stardig and Costello absent. **MOTION 2015-0547 ADOPTED**

Council Member Robinson moved that the rules be suspended for the purpose of adding Ms. Kathleen O'Riley to the list of speakers and seconded by Council Member Green, all voting aye, nays none. Council Members Stardig and Costello absent. **MOTION 2015-0548 ADOPTED**

The City Secretary began calling the list of speakers.

Mayor Parker stated as the speaker comes up she wanted to share that they instituted the heat protocol this past Saturday, that the libraries and health clinics were staying open long hours during the week and advised the Council Members to let their constituents be aware of this because of the heat.

Mr. Adrian Shelley, 394 Leeland Street, 77003, (713)528-3779 appeared and stated he was present to speak in favor of the idling ordinance, they had been working on this for quite some time and this was an important step forward for the City of Houston, it was going to be a great measure to reduce emissions from mobile sources here in the city, it was also going to be a great cost saving measure from drivers which the EPA had estimated for a single truck driver stands to save 1830 gallons every year, this ordinance will apply for aging vehicles and in the long run they want to get them off the road and when drivers were aware of it, they would comply and outreach and was going to be very important and what he meant by outreach was, outreach to big partners, outreach to the big fleets and signage in hot spots. Council Members Davis, Martin, Nguyen, Costello and Bradford absent.

Mr. Shelley was questioned at length by Members of Council. . Council Members Davis, Martin, Nguyen, Costello and Bradford absent.

Ms. Paige Powell, 394 Leeland Street, 77003, (713)528-3779 appeared and stated she was a Council Intern nine years ago, she was an Office Manager at Air Alliance Houston for 2 years, that she had been an environmentalist her entire life, she was a mother and she believes that someone gifted everyone with this Earth which everyone needs to take care of it; one of her many roles at Air Alliance Houston was going to school to teach kids about air pollution and air quality which they teach the kids that ground level ozone and smog was caused by sunlight and pollution and she believes they were at a point that it was necessary to start thinking in different ways, alternative solutions and this ordinance would get the industry to start thinking. Mayor Parker, Council Members Martin, Nguyen, Green, Kubosh and Christie absent. Mayor Pro Tem Gonzalez presiding.

Ms. Kathleen O'Riley, no address, no phone appeared and stated she was President of the Museum Park Neighborhood and she hopes that Council would consider enacting a noidling ordinance in Houston, they would be joining most other major cities in Texas that had adopted this ordinance already, it was a step forward for this city and at many field trip destinations; they originated this ordinance because they had such a problem around Hermann Park with 300 buses per day and they anticipate that this would help make people aware of the positive benefits of not idling to health and air quality and many visitors to the park and museum would be grateful for enacting this ordinance . Mayor Parker, Council Members Stardig, Cohen, Martin, Laster, Green, Costello and Kubosh absent. Mayor Pro Tem Gonzalez presiding.

Ms. Elaine Barber, 4828 Loop Central Dr., 77087, (832)657-5303 had reserved time to speak but was not present when her name was called. Mayor Parker, Council Members Stardig, Cohen, Martin, Laster, Green, Costello and Kubosh absent. Mayor Pro Tem Gonzalez presiding.

Ms. Jackie Abert, no address, no phone appeared and stated she was a volunteer at the AARP, she was retired and happy resident of Houston for 50 years and chose to spend her time and energy with AARP because it was important the work they do on behalf of older Americans and she was present to urge Members of Council to support the age friendly community. Council Members Stardig, Martin and Laster absent.

Ms. Toloria Allen, 5637 Oasis Palm, 77021, (713)419-4827 appeared and stated she was a volunteer with AARP and she was present to speak about age friendly communities, it was important that Houston develop a community action plan that would help them design a livable community that promotes wellbeing and sustains economic growth to make happier healthier residents of all ages, they knew Houston was embarking on Plan Houston which was a

framework of priorities that everyone can work on and age friendly and Plan Houston were very compatible. Council Members Stardig, Martin and Laster absent.

Ms. Janice Brantley, 4002 Carter Street, Apt 41, 77021, (713)885-4489 appeared and stated she came before Council on July 7, 2015 and July 21, 2015 about her son being wrongfully arrested and on August 4, 2015 she went to court and stated that the officers lied under oath and it was a disgrace that the law could lie under oath, it shows that the police were allowed to get away with anything and she was unable to say a word which was not fair and it was on the news every week. Council Members Stardig, Martin, Gallegos and Laster absent.

Mayor Parker stated that Judge Green was a county official; she was not a city official and according to the apartment complex her son was trespassing and Ms. Brantley was welcome to file a complaint with the sergeant who was present. Council Members Stardig, Martin, Gallegos and Laster absent.

Ms. Felesita Byrd-Barnes, 1435 Diplomat Way, 77088, (281)832-2624 appeared and stated she was a native Houstonian, a tax payer of Houston and her home was in the Willow Run Subdivision area where they received damages from Hurricane IKA and she had made application to the City of Houston Housing Development Department and she received a letter on September 11, 2013 about scheduled intake application, October 1, 2013 application intake took place, October 5, 2013 and April 14, 2014 an estimated cost of repair was performed, June 20, 2014 she was notified she was eligible for repairs to meet housing quality standards and October 2014 three City of Houston employees interrupted her recovery in the ICU to sign papers of that estimated cost and she requested copies but never received them, on December 29, 2014 another cost estimate to repairs was performed, January 12, 2015 she received a letter to tear the house down and rebuild the home, she believed her home was not in a condition to have to be torn down and when she went to meeting she voiced her concerns and provided pictures of her home in the meetings and was told that her home exceeded the \$65,000 repair cap which she still does not agree with. Mr. Frederick Sellers, 2203 Pannell Street, 77026, (713)918-9257 appeared and stated he was present to voice concerns about his water bill, he lives in a single household and his water bill had been 5,000 gallons as an average since 2009 and he recently divorced went from 5 people living in the household down to one and his water bill had not changed, he does not have a leak, he had reach out to his Council Member and the Water Department and the Water department did come out and check the meter and said the meter was fine but he believes something was wrong with the meter because there was room for error and requested the city to look into this issue. Mayor Parker, Council Members Stardig, Martin, Gonzalez and Laster absent. Vice Mayor Pro Tem Davis presiding.

Mr. Bruce Nichols, 12439 Huntingwick Dr., 77024, (713)984-2544 appeared and stated he been a proud Houstonian since 1976 and was present for the first time to appeal to City Council for help for neighborhoods in the area of TIRZ 17; the occasion was this that TIRZ 17 would be coming up for voting to Council really soon and he was requesting that Members of Council withhold the approval until TIRZ keeps a decade of promises to add flood water detention south of I10 because that promise had not been kept, homes south of TIRZ 17 had never flooded before and now they had flooded twice and development was good but they need it done. Mayor Parker, Council Members Stardig, Martin, Laster, Costello and Christie absent.

Mr. Fredrick Metoyer, 6513 Westheimer, 77057, (214)298-6088 appeared and stated he was recently arrested and he understands government, policy and procedures but it was so drastic when he went through the galleria handcuffed and he thought there should be a procedure of announcement because of some checks that happened two years ago; that Civil Rights that were voted on certain things and thought maybe he would be announced by some type of recommendation before he got a warrant for his arrest.

PUBLIC HEARING regarding amendments to the Project Plan and Reinvestment Zone Financing Plan for REINVESTMENT ZONE NUMBER TWENTY FOUR (GREATER HOUSTON ZONE) <u>DISTRICT I – GALLEGOS</u>- was presented, City Secretary stated it was a public hearing that was scheduled and no one had reserved time to speak and a presentation was made by Mr. Steven Davis and Ms. Jennifer Curley to Members of Council as followed:

Public Hearing for Reinvestment Zone No. 24

Good Morning Mayor and City Council Members. On June 24, 2015, the Board of Directors of Reinvestment

Zone No. 24, City of Houston, also known as the Greater Houston TIRZ, approved amendments to the Zone's

Project and Financing Plan and forwarded them to the City of Houston for consideration.

Harris County Commissioner's Court unanimously approved the Board's request for a boundary enlargement

on July 14, 2015. This request will be brought before this body on August 26, 2015 for consideration and approval.

Pursuant to Section 311.003 and 311.011 of the Texas Tax Code, a municipality must hold a public hearing when proposed amendments to a Project Plan include changes that increase the total project costs stated in a plan, and/or reduces or enlarges the boundaries of a Zone. This public hearing presents the First Amended Project

Plan for the Greater Houston TIRZ. I have placed a copy of the overview of the proposed amended plan in front of you. These copies are for your review prior to the complete project plan being presented to Council for consideration and approval.

The Mayor's Office of Economic Development has oversight of 23 City - Lead TIRZs. The Greater Houston

TIRZ is the only TIRZ created by the City that is County-Lead. City increment is not contributed to this TIRZ.

The intent of the Greater Houston TIRZ's proposed boundary enlargement is to address issues of blight, infrastructure need and the redevelopment of vacant or underdeveloped land uses. The proposed area represents a logical boundary for revitalization along Interstate Highway 45, Cullen, South Lockwood, Leeland and Polk

Streets and includes Magnolia Glen, also known as Fenix Estates, a public facility currently under construction.

This facility will be owned by the Harris County Housing Authority and contain its offices, permanent supportive housing, and some market rate units.

The amended plan includes:

• an annexation of roughly 193 acres, representing approximately 2% of the existing TIRZ boundary, generally described as a:
○ southern boundary of I-45;
○ a western boundary of Milby Street;
○ a northern boundary of Polk;
○ and an eastern boundary of Lockwood;

- a financing plan update that indicates a taxable value of approximately \$55.7m;
- a project plan that reflects the intent to address blighted industrial properties and vacant land in the annexation, and shows a total increase in expected expenditures of \$30m

Thank you all for the opportunity to present this information to you, and this concludes our presentation.
