The Houston City Council convened at 9:00 a.m., Wednesday, September 5, 2018 Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Marta Castex-Tatum, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; and Ronald C. Lewis, City Attorney; Marta Crinejo Agenda Director and Stella Ortega Agenda Office present. Council Member Steve Le absent on Personal Business.

At 9:09 a.m. Mayor Turner called the meeting into order and Mayor Turner recognized Council Member Cisneros for the Invocation and the Pledge and Council Member Cisneros invited Pastors Mundo and Estrada to offer the Invocation and Council Member Cisneros led the Pledge of Allegiance. Council Members Stardig, Travis and Knox absent.

The Roll was Called. Council Members Stardig and Knox absent. Council Member Le absent on personal business.

Mayor Turner stated that he was in West Houston last week on Wednesday night with Council Member Travis, the meeting was very well attended and he is amazed about people's spirits are upbeat and positive even when they are continuing to go through the recovery phase and then he was back in West Houston on Saturday night and he was visiting a number of people out there and he was walking up and down the streets and there are people that are not in their homes or there are people in their homes or people living on the second floor of their house until the first floor was ready and there are people still in the need for help and especially for Seniors because they been there for a long time and it is costly to them but overall it was a very positive meeting in West Houston.

Mayor Turner stated he wanted to advised that they will have the first Townhall Meeting tonight about the measures that are being placed on the ballet, the Rebuild Houston and well as the Firefighters Petition and that will be tonight in District C in Council Member Cohen's District that will be starting at 6:30 p.m. and they will be discussing the Petition and the ramifications it will take on the City as whole and it is very important information to get out there to the general public and the Firefighters Petition will add up to \$98 million dollars a year for the City's Budget and the question is how do they address that.

Furthermore, on Saturday they will be participating in the UNCF Walk and it would be their 33rd Anniversary in a walk for education, starting at 8:00 a.m. at the Thomas Bass Park and last year it had to be cancelled because of Hurricane Harvey.

Council Member Travis stated he wanted to thank the Mayor for his presence out at his District, it was much needed, as they can tell and many saw it in the newspaper with the picture in it and they really appreciated him for being out there.

At 9:31 a.m. Mayor Turner requested the City Secretary to call the List of Speakers.

Robin Blinn, 2100 Memorial Dr., 77007, (832)413-6193 appeared and presented information and stated that he would like to thank the Mayor and the Mayor's Staff for helping to clarify TIRZ 13's involvement in a developer's failure to install an ADA compliant bus stop planned for the 2000 block of Washington Ave., and object to the TIRZ 13 spending to install the HAWK in the 2000

block of Washington where there are no retail business, he is at the point where he is demanding spot to cross the street is the vicinity of Silver where there are several, including Taco Deli, Gus's Fried Chicken, Platypus Brewing B&B butchers & Restaurant and a HAWK signal was included in the TIRZ 2018-2022 budget locating it between Silver and White Streets but that plan has been changed and the pedestrian crosswalk is now planned for a block farther West, between White and Henderson and he would assert that people will rarely walk an additional block in order to use a crosswalk and in fact, at present , he often crosses Washington in that vicinity with little or delay in his wheelchair. Council Members Davis, Boykins, Travis, Gallegos, Knox and Christie absent.

Mayor Turner let Mr. Blinn finish his comments and stated to him that he appreciates him for bring this to their attention, they are working on it and they will make it ADA compliant, they want to make it accessible and they are talking to all the parties that are involved and they are going to address it and address this very quickly and Members of Council questioned Mr. Blinn.

Randall Baxley, 4601 Beggs St., 77009, (713)494-1981 appeared and stated that he has heard the Mayor and his mother has said, "that tomorrow will be a better day" and his mother has always said that "everyone is somebody's baby" and the fathers, mothers, grandmothers, and grandfathers are asking that those on the Northside be treated as the baby of somebody and as equal members of the family. Council Members Davis, Boykins, Travis, Knox and Christmas absent.

Eugene Szymanski, 620 Graceland St., 77009, (785)727-9257 appeared and stated that he is research Geologist for Chevron and he has worked and lived in Houston since 2010 and he is a resident of Council Member Cisneros District and he here to speak about the lawlessness in and around Lindale Park in the Near Northside and last year he and his wife brought a house there and became residents there, knowing that it is a traditional family neighborhood that is in transition with all of the large lots, tree line streets and the friendly homeowners, there are still some elements that harass the good people in the neighborhood and circling the Lindale Park neighborhood have roads, major intersections and highway underpasses that openly have beggars, drug addicts, prostitutes, homelessness with some mentally ill and this behavior that is bad seems to be throughout the whole neighborhood and getting worse since they have become residents and in the past recent months, thieves outside of Lindale neighborhood have done smash and grab in the neighborhood, broken into vehicles, houses that are right behind the Metro Rail line and even people have approached him on his own property requesting money and the most recent incident was a shooting at Calavade and Fulton intersection which is a place for drug addicts, he does not want them to think he is heartless person, he does donate and volunteer to the Houston Food Bank, Star of Hope and others, he just wants help from the local Officials and he used to use the Metro Line to get to Downtown but after couple of odd encounters, he started to use his car to drive to work. Council Member Davis absent.

Mayor Turner allowed Mr. Szymanski finish his comment and Council Member Cisneros thanked him for coming today and advised Mr. Szymanski that he is right because her office has been getting calls reporting an increase in crime and it is not the first time when they rally to get the HPD to come and it does get better for a while and they are relocated to other hotspots in the City and it comes back and it is a cycle that they are stuck in and it underlines that is why we need more Police Officers.

Mayor Turner advised Mr. Szymanski that he totally agrees with him and Council Member Cisneros and he is working to help the homeless in placing them in temporary housing to help them and that they have 5200 Police Officers and we do need more, we need hundreds of more

Officers but they do have budget issues and what they focused in one area and then they move to another area and is still in Federal Court as the ACLU filed suit and Members of Council commented and questioned Mr. Szymanski at length.

Deborah Mann, no address, (832)289-6082 appeared and stated that Mr. Szymanski was quite eloquent but she was going to point on a personal face on the same topic, they have a problem with their public safety and public transit, that she use to take the bus long before it was cool, she would walk to the bus in the dark dodging pack of dogs and men offering her a ride and assure her that they are nice guys and waiting at the bus stops she was continually harassed for money and then the train came and she was happy and she felt it would be safer and it seemed safe to walk down the street from the train station about a mile she would whistled at by men, walking along side with hookers, she always had her pepper spray in her hand but that was no match when she was robbed at gun point by a masked man a few blocks from home, the Cavalcade Station area has become a hangout for people with time on their hands and she started to get off the station a stop earlier to feels a little safer, she has called Metro on a daily basis to tell them that she feels unsafe to get off at her preferred station which she preferred Cavalcade and on Tuesday she did see that there was a Police Officer there all day and she thought to herself that she made a difference from 2 weeks of calling and then she heard that someone had been shot at the intersection of Fulton and Cavalcade which kinda burst her personal bubble but beside that point using public transportation is dangerous. Council Members Davis, Martin and Kubosh absent.

Council Member Cisneros advised Ms. Mann that she appreciates her coming today and that they did have a conversation a few weeks ago and she did share her story with Tom Lambert that is with Metro and the first words out of his mouth is asking her if he had her number because he wanted to contact her and to really understand what her experience had been and with her being here underscores the seriousness on how the crimes on the street really affect the quality of life and public safety.

Mayor Turner advised Ms. Mann that he wanted her to know that he is sensitive with all of the issues that she had pointed out and that we do need more Police Officers for the entire City of Houston but the problem is that we are capped on the money we do have and he cannot say it enough that we do need more Police Officers and he would encourage everyone what is on the Ballet this year because if they add to the City's cost and add another \$98 million dollars on our cost on other stuff or things, it going to take away what is available for public safety and they do need more resources.

Members of Council commented and questioned Ms. Mann.

Council Member Laster moved to allow more than one person at the podium and seconded by Council Member Stardig, all voting aye, nays none. Council Members Davis, Martin, Gallegos and Kubosh absent. **MOTION 2018-0456 ADOPTED**

Dr. Walter Pendleton, 1220 First St., Hempstead, TX, 77445, (832)651-4004 appeared and stated for Members of Council to view some of the events that they have scheduled, and he is related to the first Black Legislator of Texas the Reverend G.W. Wyatt who went in the Legislature after the Civil War and his picture embraces the State Corridor at the Capitol in Austin and they are here speaking on behalf of bridging the gap between bullying and they all know that bullying is a very powerful enemy that is everywhere it can go back as far as Cane and Able, it comes up even to this day and it is an issue and they came here for Council support that in October that they come together to present this in a way to come together as a whole as one to offset experience, both he and his wife have retired from NASA Scientist and they have been able to be part of some

world leading research for NASA and they thought they can use their efforts and their experiences in bridging the gap of the bullying and now she will speak on her behalf and he introduced the others that were present to speak on this event. Council Members Davis, Martin and Kubosh absent.

Dr. Alice Pendleton, 1220 First St., Hempstead, TX, 77445, (832)651-4004 appeared and stated that she is also one of the Founders of the G.W. Wyatt Congressional Ministerial Alliance and they are here to talk about bullying and as an educator and high school student because she had been encountered with bullying herself and even G.W. Wyatt went through bullying himself in his time and they are here to help the students, to handle this bullying because it is so important that students come together and not bully one another, it is important that they know that they can go to someone, it is important to have counseling and for them to talk to each other and to for them to know that bullying is not right. Council Members Davis, Martin, Gallegos and Kubosh absent.

Mayor Turner thanked them both for being present.

Robert Santee, 1914 Quail Valley, Missouri, TX, 77459, (713)297-1738 appeared and stated that he is here on behalf of the G.W. Wyatt Congressional Ministerial Alliance and he is the President of G.W. Wyatt Congressional Ministerial Alliance and he wanted to extend his hand to the Mayor and Council Members that they would truly appreciate it if they would attend this event and he presented the dates and he himself have come up from Acres Homes and this would be held at 1620 Dolly Wright Street, they have fought hard for the kids and they appreciate the Council for given them the opportunity to speak on this today, it is a good program and they need it, so many kids are getting mistreated out there and for himself as an x-former Astro, he would like to be able to help these kids and Calvin Murphey is going to be part of it and he wanted to thank Council Members Knox and Kubosh for participating in this event and he appreciates the Mayor on the things that he is doing and they would truly like to have him there it starts October 25 -28, 2018. Council Members Davis, Martin, Gallegos and Kubosh absent.

Tracy Thompson, 22535 Spring Link Ct., Spring, TX, 77373, (281)889-4357 appeared and stated that she is going to piggy back on the event that they are going to have in October that is in Acres Homes and it is called Bridging the Gaps and the reason they picked that title they just do not want to focus on the kids that are being bullied, they want to focus on the kids that are doing the bullying, they have to go back and finger out why they are doing the bullying, the 4 day event will be breakout sessions, they will have a fashion show to help kids with self-esteem, they will have playing for a cause and on Thursday they are going to have a mix and mingle and they are going to have some teachers come out and counselor come out and from her understanding is that the teachers and the Counselor do not have the resources from the school to take time out to focus on the kids that are being bullied and kids that are the bullying and they want to get their input in hopes of taking that information in and bring it back here to try to get more resources for the school and she is the Founder of CICA Inc. which is a non-profit organization and she wanted to thanked them and she hopes to see them out there in October. Cedric Washington, 3013 Rosedale St. #3, 77004, (832)715-8492 appeared and presented information and stated that there was something that he wanted to discuss before them this morning and it deals with affordable housing and he knows that this issue has come up before them in past times and his concern for the City, just like Police and the safety and particularly he is concerning the elderly and there is an elderly community that is spread out over Houston and sometimes for examples Law enforcements cannot get to them when and to the truth is that we

all are aging, he has worked with Saint John's Downtown for 6 in half years in terms of feeding the needled, helping with their food drive, a book drive for the children and he works with disadvantage families and in some of the communities he has to see that grandparents have to step in and have to help out and sometimes their areas and housing are not the best situation but it just not that, look at what happen last year in terms of Hurricane Harvey, rescue missions can be a challenge when they have forks in wheelchairs, crutches and that type of thing and what he is suggesting to the City that they look at the shipping containers simply because they are affordable, they are durable, they can stand the weather and he thinks in a lot of these areas and they can build community houses with them and it is really important to take a look at that, the cost would not be as much in terms of repair damages which then he presented the examples for the Council to look at, there could be shelter for the elderly can use that and to kind of do what the City of Detroit did but he does not think anyone can do it better then Houston, we have the time, the land, the resources, he researched this for 9 years. Kevin Hoffman, 516 Avenue of Oaks, 77009, (713)305-5468 appeared and stated he wanted to thanked them for the lovely discussion on Civility Ordnance and homeless issue along the light rail line and around the Near Northside when the Civility Ordinance after the death of Jose Flores, the Council and the Mayor had said that they would work together to come up with a more long range solution and after listening to today discussion, it appears that they have not really thought much about that and he would encourage them to see what other solutions are out there and couple of the Council Members have come up with working with all of the Law Enforcements in Houston and surrounding areas and we need to help them understand the importance of working with the City and there have been some issues in the Cavalcade station and the issue was one Law Enforcement agency was advising the people that was calling in about the issues over there that they need to contact this Law Enforcement and then that Law Enforcement would says it is this law enforcement and the call never got addressed and over the weekend there was a shooting at that station and since that shooting has happen they do see Metro Police Officers all around the red line, everyday since the shooting, why did it have to wait until that time to see Metro Police Officers at the line and one day in the same area he was driving and when he was at a stop he saw a drug deal go down and a HPD Officer also saw the exchanged and he did nothing and like Council Member Boykins stated that there are other Ordinances that can be enforced. Council Members Boykins, Martin and Travis absent.

Mayor Turner advised Mr. Neal that he was reassessed for permanent supportive Housing on July 30th of this year and they referred him to the VA Voss Supportive Housing and he knows that the Mayor's Office has reached out to the VA to try to get an update on him and Sean which is standing behind him and he is here to assist him in getting the support that he needs.
