A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, April 20, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director present. Council Member Martha Castex-Tatum out of the City on City Business.

At 1:50 p.m., Mayor Turner called the meeting to order and recognized Council Member Thomas for a proclamation.

Council Member Thomas presented a proclamation honoring Reverend Rhett Caviel to recognize the countless community services projects he has done to serve District F.

At 1:58 p.m., Mayor Turner recognized Council Member Kubosh and he invited Reverend Rhett Caviel for the Invocation after which he led the Pledge of Allegiance.

#### **MAYOR'S REPORT**

Mayor Turner stated that the Hire Youth Summer Program applications deadline was extended to Friday, April 23, 2021. Council Members were asked to please join him in reminding students in there's respective districts, between the ages of 16 to 24, that if they were looking for a summer internship, that is either with the City or with private companies, to go to the portal hirehoustonyouth.org and they can apply. The same thing goes to businesses who are looking to hire and invest in the lives of younger generations, they can do the same by going to hirehoustonyouth.org and to indicate that they would like to hire summer interns. Because of the coronavirus, their goal is to at least have 5,000 summer interns this summer and then we will get back to where we where in 2019 when we had over 10,000 summer intern jobs.

The Chief of Police, Troy Finner officially announced yesterday his new Executive Command Staff appointments. He filled some critical vacancies and named a diverse group of well qualified and experienced police officers to help him lead the Department and get a handle on the crimes in the City of Houston.

Mayor Turner stated that starting on Saturday, April 24, 2021 the Houston Health Department is adding 2 additional targeted community vaccination clinics this week. The Department clinics are located in the priority zip codes and offer free doses of Moderna COVID-19 vaccine with or without appointments. Each site opens up from 8:30 a.m. to 4:30 p.m. at Community Family Centers, Sport and Recreation Buildings at 7318 Avenue F (1,000 doses) and then the Greater Saint Matthew's Baptist Church (700 doses). Also, at Mission Milby Community Development Corporation. Appointments are available but walk-ins are available from 8:30 a.m. to 4:30 p.m. or until the site reaches its daily capacity. Again, Houstonians can now get the Pfizer vaccination at NRG Stadium Park without an appointment daily from noon till 9:00 p.m.

A quick update on the Houston Harris County Winter Relief Fund. A lot of Houstonians are still dealing with the impacts of busted pipes. A total of \$15.7 million has been raised for this fund which is also detailed in the report that was just released. This week, the grants committee authorized a third round of grants for home repairs in the amount of \$2,650,000.00 to eight nonprofit partners to help with the rebuilding and that money will be disbursed this week and all funds expected to be disbursed by the end of May. Mayor Turner wanted to thank all of the Board Members, the Greater Houston Community Foundation, United Way and all of those that have contributed to this fund.

This is Earth Week and the Solid Waste Management Department is hosting a virtual event to help protect our planet and encourage recycling education. He knows that some people still have questions about whether you should recycle a plastic bottle or what happens to the glass when you put it in the green recycling cart. You can register for this event online on Solid Waste's Facebook page and there you will have the opportunity to ask questions of the recycling experts.

Today, at 11:30 a.m., we will be celebrating the 1<sup>st</sup> anniversary of the Houston Climate Action Plan. We will join with the nonprofit group, Solar United Neighbors, (SUN), to announce the launch of the Citywide Solar Co-Op. The event will take place in front of City Hall.

And lastly, if you look into the sky at night, the birds are migrating. A reminder that the City of Houston is observing "Lights Out Night" from April 19<sup>th</sup> through May 7<sup>th</sup> and he is encouraging businesses, residents and building managers to turn off the nonessential exterior lighting from 11:00 p.m. to 6:00 a.m. during the period of peak migration for birds through Texas.
