A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, April 27, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director present.

At 1:43 p.m., Mayor Turner called the meeting to order and recognized Council Member Thomas for the first proclamation.

Council Member Thomas presented a proclamation honoring Patrick Hoang to recognize his selflessness and willingness to serve the community in the aftermath of Winter Storm Uri.

At 2:01 p.m., Mayor Turner recognized Council Member Thomas for the Invocation after which she led the Pledge of Allegiance.

The Houston City Council reconvened at 9:00 a.m., Wednesday, April 28, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. At 9:02 a.m. Mayor Turner called the meeting of the Houston City Council to order and requested the City Secretary to call the roll.

REPORT FROM CITY CONTROLLER AND THE CITY ADMINISTRATION REGARDING THE CURRENT FINANCIAL STATUS OF THE CITY including but not limited to, a revenue, expenditure and encumbrance report for the General Fund, all special revenue funds and all enterprise funds, and a report on the status of bond funds and a Quarterly Investment Report by the City Controller - Was presented, City Controller Chris Brown and Director of Finance Department Tantri Emo, reviewed the Monthly Operation, Financial Report and Quarterly Investment Report; copies of which are on file in the City Secretary's Office for review.

Council Member Martin moved to accept the Monthly Financial Report & Quarterly Investment Report and seconded by Council Member Castex-Tatum, all voting aye, nays none. Council Member Thomas absent. **MOTION 2021-0198 ADOPTED**

At 9:12 a.m., Mayor Turner requested the City Secretary to call the Public Hearing

1. **PUBLIC HEARING** regarding a proposal to amend Land Use Assumptions, a Capital Improvements Plan, and Impact Fees in accordance with Chapter 395 of the Texas Local Government Code – Was presented,

Mayor Turner read the following statement: The Public Hearing is being held in accordance with the Texas Local Code Government, Chapter 395 and the requirements of the Texas Government Code Chapter 551. By law the City of Houston must update its land use assumptions, impact fee Capital Improvements Plan, maximum calculated impact fees per service unit and recommended water and wastewater and impact fees at least every 10 years. To satisfy the update requirements, the City of Houston had to perform an engineering study and approve the findings of the study to amend existing impact fees and adopt new impact fees by the time the current updates expire on July 1, 2021. The City engaged Carollo Engineers, Inc. to secure the City's efforts in performing the regional updates in 2019. The detail findings of this effort are set out in the 2020 cost of service study water and wastewater impact fees update. The City must adopt the land use assumptions impact control improvements plan, maximum calculated impact fees per service unit and recommended water and wastewater impact fees and adopt new water and wastewater impact fees by July 1, 2021. Notice of the impact fees update and this public hearing on land use assumptions, the Capital Improvements Plan, maximum calculated impact fees per service unit and recommended water and wastewater fees impact fees are posted on the City Secretary website and in the Houston Business Journal at least 30 days before this public hearing. Then Planning Commission, acting as the impact fee Advisory Commission, also considered these four items at its April 1, 2021 meeting and provided written comments to the City Council on April 20, 2021 as required by Chapter 395. Then Planning Commission's written comments are also posted on the City Secretary website.

City Council action considering the impact fee update and updates to the land use assumptions impact fee Capital Improvements plan, maximum calculated impact fees and recommended water and wastewater impact fees will be taken in May to meet legal requirements for action on the updates and amendments of impact fees by July 1, 2021. The guidance amending water and wastewater impact fees may not be done on the emergency basis. For these hearings, they will be given a presentation from the Houston Public Works Director and after that we will hear on any public speakers on the public hearing.

Carol Haddock, the Director of Houston Public Works and she is joined by Samir Solanki, Chief Financial Officer, to present a power point presentation to members of Council.

No one signed up to speak on this Public Hearing. The Mayor requested a motion to close the Public Hearing; Council Member Castex-Tatum moved to close this Public Hearing and Seconded by Council Member Robinson, all voting aye, nays none. Council Member Thomas absent. **MOTION 2021-0199 ADOPTED**

 PUBLIC HEARING regarding a proposal for the City of Houston to update amounts charged for Water and Sewer Utility Services under Chapter 47 of the Code of Ordinances, Houston, Texas – Was presented,

Mayor Turner read the following: Access to safe drinking water and wastewater treatment is one of the most fundamental daily services that is provided by the City of Houston. Our existing water infrastructure is aging, and many neighborhoods are served by lines nearing 50 years in service. While there are programs to repair the system, such as the 1990's Greater Houston Water and Wastewater Program, regional conversion from groundwater to surface water in the 2000's, it has been a legacy of under investments in our neighborhoods utilities due in part to limited funding. Now, we have accepted a new commitment and the City has taken positive steps to invest in Houston water and to serve our customers better by providing more affordable, equitable and legal complaint utility services. For example, in improving the consent decree for our wastewater system, we commit to correct infrastructure in our neighborhoods and bringing forward these new water and wastewater rates, and impact fees, we provide the financial support needed to accomplish our goals for Houston water. We cannot ignore the challenges of today such as climate change, equipment failure and our special challenges of drought and flooding. We are committed to moving from the simply reactive posture to committing to resilience. The subject of this public hearing, water and wastewater rates, along with the impact fees we discussed earlier may be the most important step in our path to resilience to Houston water. Resilience to future man made and natural disaster is built into our system and revenue support for financial stability and it's important that we have a water and wastewater system that is reliable and dependable that can function in times of extreme weather condition. Mayor Turner recognized Director Haddock again for another presentation.

Carol Haddock, the Director of Houston Public Works and she is joined by Samir Solanki, Chief Financial Officer, to present a power point presentation to Members of Council.

No one signed up to speak on this Public Hearing. The Mayor requested a motion to close the Public Hearing; Council Member Castex-Tatum moved to close this Public Hearing and Seconded by Council Member Robinson, all voting aye, nays none. Council Member Thomas absent. **MOTION 2021-0200 ADOPTED**

MAYOR'S REPORT

Mayor Turner stated that the Houston Health Department started to accept walk-ins at all of the Houston COVID-19 vaccination sites and hours have been extended at some of these sites to make it easier to have people to get the vaccination. You don't have to register. You can simply walk-in at all of the Houston sites and he encourages people to just do that. For people you have gotten the vaccine but haven't returned for their second shot, he encourages people to come back for the second shot. The Health Department is reaching out.

There is some exciting news this morning. Two of the most prominent energy conferences in the world, the Offshore Technology Conference (OTC) and NATE Summit announced their first of its kind synergy in energy partnership that will take place here in Houston. OTC will be held at the NRG Park from August 16th through 19th and the NATE Summit will be held at the George R. Brown Convection Center on August 18th and 20th. This is the first time we have these 2 big conferences that are convening together, and the partnership is expected to draw thousands of energy professionals around the world to discuss important issues facing the Global Energy Industry, such as the impact of the pandemic on industry business models. Both events will follow the latest local COVID-19 safety guidelines and allow participants to attend in person or virtually. They are scheduled to make this announcement at 10:00 a.m.

Solid Waste Management Division is launching a curbside recycling cart tagging pilot program and more information will be released later this morning. The 6 - month pilot program will sample 60,000 of the 390,000 homes that the City of Houston provides services too. The goal is to educate people and provide real time feedback on the contents of a residents' recycling cart. For example, a team of observers will visit each resident's location on collection day and provide information on how to improve the contents their recycling cart. One of the reasons is because we are having a great deal of contamination in their recycling bins. If non-accepted items are found in the bins, observers will leave a an "Oops Tag" on the cart. (which Mayor Turner presented/showed the tag that the residents will receive.) After the first or the second "Oops Tag" then they may get a rejection. The goal is to educate people and to enhance what's in the recycling bins.

Mayor Turner wanted to remind that the Turn Around Houston Jobs Readiness Fair will be held virtually on Thursday, April 29th through Sunday, May 2nd. More than 2,000 open positions have been added to the job fair and job seekers can chat live with hiring employers and resource organizations from 10:00 a.m. to 2:00 p.m. on Thursday. Registration is required to access the portal and for more information to please go to www.houston.tx.gov/turnaround. Positions are available for all skill levels and job seekers. Turn Around Houston is for people that are having a difficult time in finding a job. Please spread this information out to everyone.

Friday, April 30th is National Adopt a Shelter Pet Day and BARC is joining with other rescue groups for virtual and in-person adoption events. BARC adoption hours are at 11:00 a.m. to 5:00 p.m. and they are located at 3300 Carr Street. For more information, go to the City of Houston website or the BARC Facebook page.

Mayor Turner wanted to congratulate Sheriff Edward Gonzalez. Yesterday, the Biden Administration nominated him to lead the Immigration and Customs Enforcement Agency. ICE is a challenging job, but the Sheriff is an experienced former Houston Police Officer and City of Houston Council Member and we wish him well. Also, Director Steve Hall from the

Mayor's Office of Veterans Affairs has been recruited by the Biden Administration. He will be leaving, and we wish him well. Tomorrow at 11:00 a.m., the Mayor will announce the Task Force on Police Reform recommendations that the additional steps we will be taking to implement the Mayor's Task Force on Police Reform.
