Council Chamber, City Hall, Tuesday, January 25, 2022

A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, January 25, 2022, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn, Randy Zamora, Legal Department, and Marta Crinejo, Agenda Director, present.

At 2:00 p.m., Mayor Turner called the meeting to order and recognized Council Member Peck for the Invocation and Pledge of Allegiance.

Council Member Peck for the Invocation and she invited the North Brook High School Choir to give the invocation after which she led the Pledge of Allegiance.

Mayor Turner requested the City Secretary to call the roll.

Council Member Castex-Tatum moved to delay the minutes and Seconded by Council Member Robinson, all voting aye, nays none. **MOTION ADOPTED**

Due to health and safety concerns related to COVID-19, this meeting will offer the options to participate by videoconference or in-person. The meeting will be open to the public but restrictions regarding masks, allowable room capacity, and seating arrangements may be in place.

The public meeting location will be City Hall Council Chamber, 901 Bagby, 2nd Floor, Houston, Texas 77002. The Mayor, as presiding officer of City Council, and some Council Members will be physically present. Other Council Members will be participating by videoconference in accordance with the provisions of Section 551.127 of the Texas Government Code applicable to a governmental body that extends into three or more counties. The meeting will also be streamed as usual on the City's website (https://www.houstontx.gov/htv/index.html), Facebook site (https://www.facebook.com/pg/HoustonTelevision/videos/) and the municipal channel on public television.

Mayor Turner stated that he wanted to review some of the procedures for conducting the Virtual Public Session. He is requesting for Council Members to speak slowly and clearly because this will help the City Secretary, the closed captioner and the general public. After roll call, they established there was a quorum. If by chance, for example, they have to leave, just let them know on the chat screen if they are leaving temporarily or if they are leaving for the duration because otherwise, they will assume that Council Members are present. If they are making the motion or seconding a motion, they will need to state their name and their action clearly so they can have it down for the record. The Agenda Director will be monitoring the chat and will provide him their names. Please don't use the chat room just for chatting. Please mute themselves when they are not speaking and unmute themselves when they are recognized to speak. For the general public, in order to be recognized as a public speaker, they have to sign up for the meeting on Monday by 3:00 p.m. in the Office of the City Secretary and then they will call the speakers name in the order that they have signed up. When their name is called, press *6 to unmute themselves. They may only speak when recognized and to please note that if they speak during the meeting and he hasn't recognized them, he will have to mute and/or remove them off the call.

Mayor Turner stated that bear in mind they have a long list today and because the Speaker's List is 152 minutes, it triggers the one minute rule and request the City Secretary read the rule by which we will be governed by during this meeting.

The City Secretary stated not withstanding the provisions of subsection a, if the total of the times requested by speakers at any council meeting is greater than 150 minutes, the mayor shall so announce and each speaker's time shall be one minute. Furthermore, when the provisions of this subsection are invoked, the question time for city council members shall be limited to a cumulative total of one minute for each speaker, not withstanding the provisions of this rule and rule 10 to the contrary.

MAYOR'S REPORT

Mayor Turner stated that he wanted to congratulate the newly elected member of City Council. Yesterday was election day in District G, a seat that is currently being held by Council Member Travis. Mary Nan Huffman won the election with 54% of the vote. She will succeed Council Member Greg Travis and he had the privilege of talking to and congratulating her last night on a very important win. He indicated that they are all looking forward to working with her and she is looking forward to working with them, as well. They will canvass the vote on next Wednesday and she will be sworn in as well. Mayor Turner stated he and Council Member Travis came into office together in 2016 and he is going to be venturing off on other endeavors. Mayor Turner stated he will be presenting Council Member Travis with a certificate and a pin from the City of Houston for 5 years of meritorious service to our community.

Mayor Turner stated Council Member Cisneros came in at the same time and he wants to present her with a certificate and pin for 5 years of meritorious service to our community. He told Council Member Travis that they will miss him and wishes him the very best.

This morning, they received a positive report from the EPA Administrator, Michael Reagan, in response to his visit to Houston's Fifth Ward and Kashmere Gardens neighborhoods. He hopes they can recall that the city joined in with the residents out in the Fifth Ward/Kashmere Gardens area with respect to the creosote cancer cluster site. We asked the administrator to take an active role. This morning, he announced bold actions to protect communities following the Journey to Justice Tour. He wanted to thank Administrator Michael Reagan and the EPA for their quick follow up actions. During his visit to Houston, Mr. Reagan he had the opportunity to hear directly from the people and toured the neighborhoods. The Mayor wanted the residents to know the partnership between the EPA and the City of Houston is focused on them and improving the quality of life of the people in those communities. He certainly appreciates the collaboration between the EPA and the City of Houston. It's very encouraging to have the administration share their concerns and know the names and faces of those affected.

On Saturday, January 29th, the Houston Health Department will be launching a new program to encourage more Houstonians to get vaccinated against COVID-19. People who get their first dose or booster shots between January 29th and March 10th will be entered into a drawing for a \$1,000 gift card. The program is a partnership with Houston in Action and Human Age Digital, which received \$50,000 in grant funds to support efforts to increase vaccination rates in Houston. This week, the City of Houston joins the Coalition for the Homeless and others partners to canvass the Houston region to count and survey every homeless individual residing on the streets. The actual count is required by the federal government for communities receiving federal homeless funding. It helps determine the size of the homeless population and Houston has made a lot of progress in housing our homeless.
