# Council Chamber, City Hall, Tuesday, June 1, 2022

A regular meeting of the Houston City Council was held at 9:00 a.m., Wednesday, June 7, 2022, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Mary Nan Huffman, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Arturo Michel, Legal Department and Marta Crinejo, Agenda Director, present.

At 9:05 a.m., Mayor Turner called the meeting to order.

Mayor Turner recognized Council Member Jackson for the Invocation after which she led the Pledge of Allegiance.

# **ROLL CALL**

Council Member Castex-Tatum moved to adopt the minutes of April 26-27, 2022 and Seconded by Council Member Martin, all voting aye, nays none. **MOTION ADOPTED** 

Due to health and safety concerns related to COVID-19, this meeting will offer the options to participate by videoconference or in-person. The meeting will be open to the public but restrictions regarding masks, allowable room capacity, and seating arrangements may be in place.

The public meeting location will be City Hall Council Chamber, 901 Bagby, 2nd Floor, Houston, Texas 77002. The Mayor, as presiding officer of City Council, and some Council Members will be physically present. Other Council Members will be participating by videoconference in accordance with the provisions of Section 551.127 of the Texas Government Code applicable to a governmental body that extends into three or more counties. The meeting will also be streamed as usual on the City's website (https://www.houstontx.gov/htv/index.html), Facebook site (https://www.facebook.com/pg/HoustonTelevision/videos/) and the municipal channel on public television.

Mayor Turner stated that he wanted to review some of the procedures for conducting the Virtual Public Session. He is requesting for Council Members to speak slowly and clearly because this will help the City Secretary, the closed captioner and the general public. After roll call, they established there was a quorum. If by chance, for example, they have to leave, just let them know on the chat screen if they are leaving temporarily or if they are leaving for the duration because otherwise, they will assume that Council Members are present. If they are making the motion or seconding a motion, they will need to state their name and their action clearly so they can have it down for the record. The Agenda Director will be monitoring the chat and will provide him their

names. Please don't use the chat room just for chatting. Please mute themselves when they are not speaking and unmute themselves when they are recognized to speak. For the general public, in order to be recognized as a public speaker, they have to sign up for the meeting on Monday by 3:00 p.m. in the Office of the City Secretary and then they will call the speakers name in the order that they have signed up. When their name is called, press \*6 to unmute themselves. They may only speak when recognized and to please note that if they speak during the meeting and he hasn't recognized them, he will have to mute and/or remove them off the call.

# **MAYOR'S REPORT**

This morning, the City of Houston will honor the victims of the Uvalde School shooting. On the first few rows in Council Chamber, there are nineteen (19) backpacks, two (2) flower bouquets and a photo of each person killed. The Mayor's Office created the tribute to remember the children and teachers who died in their classrooms at Robb Elementary School. Houston will continue to lift the families and the Uvalde community as they try to heal and make sense of this unthinkable tragedy. These funerals will take place over the next couple of weeks. He also wants to point out that Director Carol Haddock grew up in the Uvalde area and attended the same school, so it's very personal to her.

Yesterday, we announced that for the first time in more than a year, Houston's homicide rate is showing a 3% decline. It's an indication of the efficacy and the impact of the One Safe Houston Initiative, a comprehensive public safety plan aimed at wholistically addressing and rebuilding the public safety ecosystem in Houston. A great deal of credit goes to our law enforcement community, from the federal level down to our community participants, themselves, for making that happen.

The Mayor stated today starts the 2022 Hurricane Season. He encourages every Houstonian to have a plan and an emergency kit for at least three (3) days. He encourages people to buy water now instead of waiting until the storm is five (5) or six (6) days away. He also encourages those, who can afford it, to get flood insurance. Whatever it is that you need, get prepared now. We are expecting an active hurricane season.

The Freedom Over Texas will be back. No restrictions on the crowd this year. It will take place on July 4<sup>th</sup>. Houston's own, Clay Walker, will be headlining the event. Step Rideau and the Zydeco Outlaws will also be out there. Please plan now to attend the event. The Juneteenth event will take place at Emancipation Park on June 18 and 19 from 4:00pm to 10:00pm each night.
