A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, October 11, 2022, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Tiffany Thomas, Mary Nan Huffman, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director, present. Council Members Dave Martin and David W. Robinson absent. Council Member Mike Knox absent on personal business.

At 1:40 p.m., Mayor Pro Tem Martin called the meeting to order and recognized Council Member Cisneros for the first proclamation.

For the general public, in order to be recognized as a public speaker, they have to sign up for the meeting on Monday by 3:00 p.m. in the Office of the City Secretary and then they will call the speakers name in the order that they have signed up. When their name is called, press *6 to unmute themselves. They may only speak when recognized and to please note that if they speak during the meeting and he hasn't recognized them, he will have to mute and/or remove them off the call.

This is National Code Compliance Month and October is when we recognize Code Enforcement Officers and professionals for the important work they do year-round in our City. Many of the City's Code Enforcement Officers are here along with the department directors, Takasha Francis (DON), Carol Haddock (HPW), Chief Sam Peña (Fire), Asst. Fire Marshall Richard Galvan (Fire) and Chris Butler (HPW-Permitting). The Department of Neighborhoods Inspectors carry out an average of 48,000 inspections each year on single-family residential properties. Houston Public Works Code Enforcement Officers conduct inspections and issue permits for more than 30,000 projects annually. The Houston Fire Marshall's Office Life Safety Bureau conducts over 27,000 inspection activities each year and supports Houston Public Works' Plan Review processes and safety systems. He asks that residents continue to help in this effort by reporting suspected code violations to the 3-1-1 Help Line. On behalf of the City of Houston, he invited all colleagues to join him in thanking these inspectors.
