








International Terminal Processor – Building Model (South Side)





Enabling Utilities Landside (EUL) Project

Project Summary

- Construct a new Water Production Plant (HIA#3):
 - Pumping station.
 - Two 1.2 million-gallon aboveground potable water storage tanks.
 - A new water well with supporting infrastructure.
- New water distribution line to CTA:
 - Water Line scope includes installing over a mile of underground water main with a combination of open cut/horizontal drilling/jack and bore.
- Replacement of some of the aged water distribution line.
- Installation of isolation valves to maintain the water pressure in the CTA when water service area drops below 35psi.
- Triturator scope is an above-ground covered structure with truck bays and a recessed grinder pit.
- The contract or is Burns & McDonnell Engineering with an appropriation request of approximately \$49M.
- The construction completion is forecast for Q1 2023.
