

Thermal Imaging Cameras


- Evaluated and selected by HFD Firefighters
 - Single button use FLIR K33
 - Better display quality
- Provide crucial insight for search & rescue
- 119 Units Replaced this year
 - 47 Units Purchased by District F, G, AL 1 & 5
 - \$118,000 CDF Investment

Program Improvements

- Improve our process of keeping gear clean and firefighters safe
- Funding assisted by Firefighter Foundation of Houston FFFH
- District A, G and E
 - \$95,682 for Extractors- Gear Cleaning
- Total facilities 94 (Arson & Academy)
 - 59 currently installed
 - 35 outstanding



Total Investment ~\$33.2 Million*




Ambulance Service Demand



- EMS incidents account for 87% of HFD workload
- Call volume has increased over 16% in the last 7 years
- Increase is completely driven by EMS call volume
- Peak time demand between 1100 and 1800
 - EMS Resource Management in effect 13% of the time
- Dispatch adjustments in attempts to send the most appropriate resource have been made to over 37 medical call types
- Dispatch adjustments have made limited impact on Ambulance capacity.
- Additional Ambulance Units needed in the system




HFD Staffing Level








Attrition vs. Recruits
