Background of Letter of Approval (LOA)



In 2013, the Texas Legislature passed Senate Bill 8 and in part, amended section 773.0573 of the Health and Safety Code to provide that an emergency medical services ("EMS") provider applicant (for a state license) must obtain a letter of approval from the governing body of the municipality in which the applicant is located and is applying to provide emergency medical services.

Background of Letter of Approval



Section 773.0573 states the municipality may issue a letter of approval if the governing body determines that:

- (1) The addition of another licensed emergency medical services provider will not interfere with or adversely affect the provision of emergency medical services by the licensed emergency medical services providers operating in the municipality or county;
- (2)The addition of another licensed emergency medical services provider will remedy an existing provider shortage that cannot be resolved through the use of the licensed emergency medical services providers operating in the municipality or county; and
- (3)The addition of another licensed emergency medical services provider will not cause an oversupply of licensed emergency medical services providers in the municipality or county.



The Houston Health Department issues permits for private ambulance companies that operate in the City of Houston.

Emergency transport is strictly a Houston Fire Department duty.

An HHD Permit allows private ambulances to transport patients for nonemergency purposes.

Number of events HFD responded to a facility due to a lack of private ambulance provider (nonemergency transport was made)


