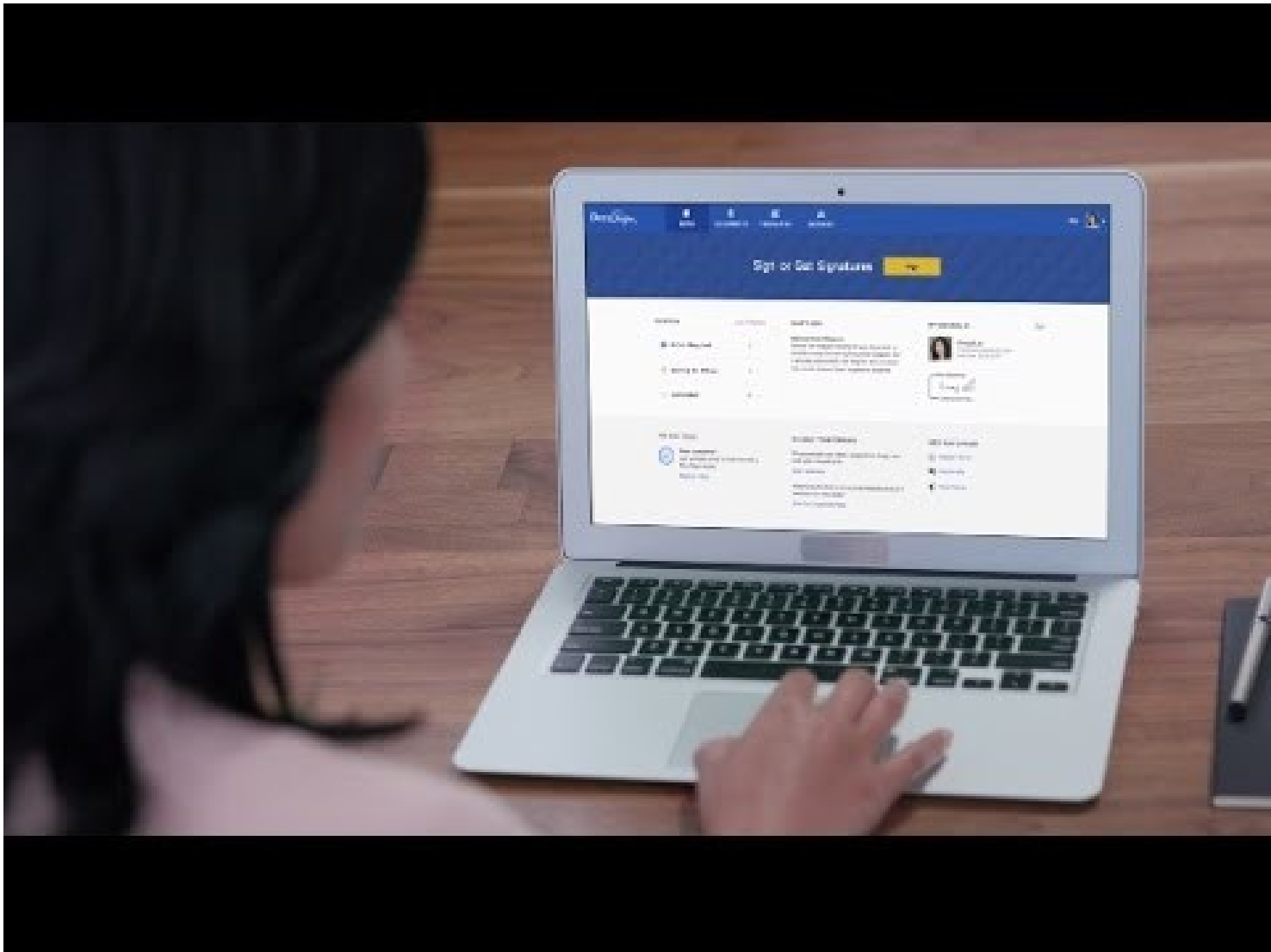

Bottom Line Up Front: eSignature

Vendor	Pure Business Solutions
Purpose:	Streamline document approval process to create efficiencies and act as a precursor towards diminishing costs associated with paper waste.
Solution:	Software solution provided by the vendor selected via competitive process is DocuSign
Contract Amount:	\$1,424,840 spending authority over the contract term
MWSBE	0% due to majority of spend being license purchases, but Pure Business Solutions is a registered MWSBE partner
Hire Houston First	Pure Business Solutions is a Houston Based company

Considerations for selecting an eSignature product

Security and Controls	DocuSign provides the highest level of security assurance as the only eSignature company to be both ISO 27001 certified and SSAE 16 examined and tested. They are also working on FedRamp certification, Federal Risk and Authorization Management Program, which is a government-wide standard
Auditability	Certification of Completion for all documents for which they are a signee or recipient. All aspects of each transaction are fully logged (including name, email address, IP address, date/time, and user unique pin) and captured in a detailed transaction history which is stored as redacted and encrypted data.
Easy of use	DocuSign is a commonly used eSignature product for everyday users. Very little, if any, training is required for document approvers.
Multi-channel	Remote – mobile device, laptop, tablet, etc. In-Person – Signature capture devices Embedded – Integration with web portals or applications Mobile signing – Supports signing Remote and In-Person modes or offline Signing on Paper – to allow signers to output, wet-sign and then upload or fax the documents back into the DocuSign workflow.
Licensing	Licenses only required for those initiating/routing the document. Signers do not require a license.
