



RESIDENTIAL

PLAN REVIEW PROCESS CHANGES

- separate review lines based on project complexity
- 2 realignment of plan review staff
- 3 new performance goals
- 4 quarterly meetings with all departments
- 5 electronic plan review & process enhancements

PERFORMANCE GOALS | CURRENT VS. PROPOSED

TYPE	DESCRIPTION	CURRENT GOAL (all submittals)	PROPOSED GOAL (submittal / resubmittal)
COMMERCIAL			
LIGHT	remodels, tenant improvements design time: 1 – 2 months	15 days*	10* days / 7 days
MINOR	new restaurant buildouts, shopping center buildouts design time: 3 – 6 months	15 days	15 days / 10 days
COMPLEX	any ground up construction design time: 12 – 18 months	15 days	25 days / 15 days
RESIDENTIAL			
SINGLE FAMILY	any ground up construction design time: 1 – 2 months	10 days	10 days / 7 days
