
Bottom Line Up Front

RADIO SYSTEM OVERVIEW

- Over 50 radio tower sites equipped with towers, equipment shelters, transmission equipment, generators & DC power systems
- 25,540 radios operational on the system
- Portable and Mobile Radio Inventory
 - Police 6,682 (Portable), 2,107 (Mobile)
 - Fire 1,450 (P), 650 (M)
 - HITS 676 (P), 643 (M)
 - PWE 391 (P), 61 (M)
 - SWD 621 (M)
 - COH Radios 12,166
 - External Agency Radios 6,649
- FY20 Radio System Availability was 99.9953%
