
New Software Overview

Existing Plat Tracker Software

- In-house developed custom web-based application that allows land planners, civil engineers, and surveyors to submit subdivision plat applications for review and approval by the Houston Planning Commission.
- Applicants and the public can track the progress of plat applications. Regional agencies use Plat Tracker to share files and communicate their comments to the Planning staff.
- Currently, Plat Tracker supports approximately 5,000 organizations and users and is used by multiple agencies to provide comments to the Planning staff.





Existing Historic Preservation Tracker

- The Historic Preservation Tracker (HPT) application was built off the Plat Tracker program and went live in 2018. This application is used to track developments and alterations to historic properties and track projects based on historic, protected, or archeological designations for HAHC (Houston Archeological and Historical Commission).
- It serves as a mechanism to gather uploaded documents from the customers and enforce submittal deadlines.
- Owners and their agents to submit Certificate of Appropriateness (COA) applications
