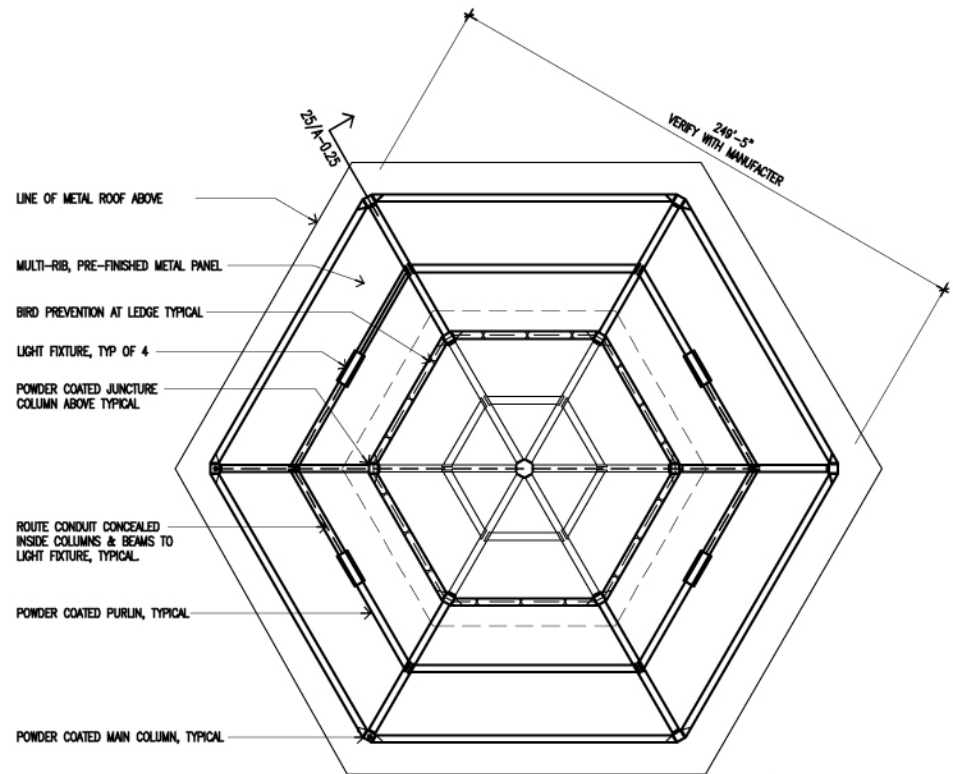

TYPICAL LIGHT-STRUCTURE SYSTEM DETAIL - 5 FIXTURES

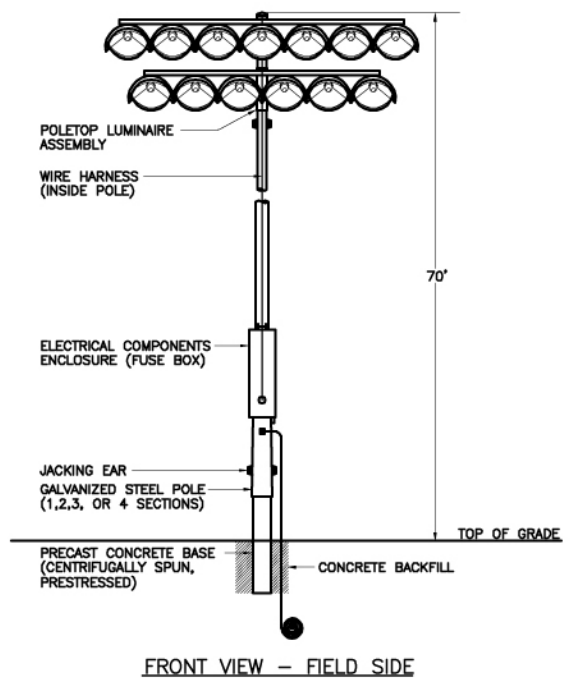

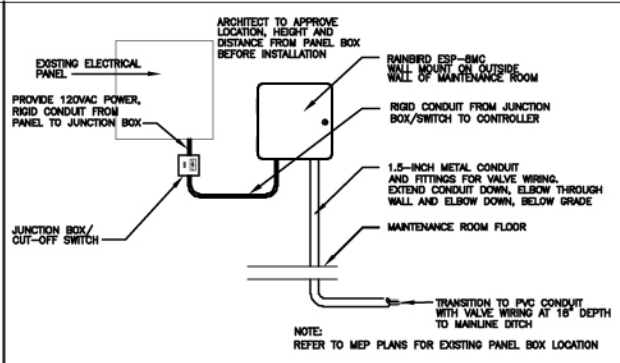

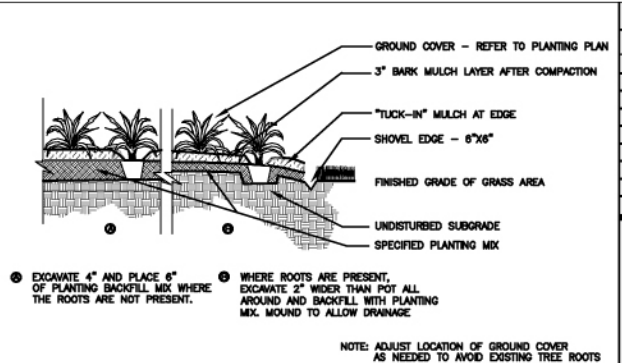
FRONT VIEW - FIELD SIDE
